Summer during her treatment

A brave little girl from Ponteland will celebrate her recovery from cancer with a dream holiday to Disneyland, Florida.

For family, friends and other generous well-wishers have donated nearly £6,000 to five-year-old Summer Robinson, who has endured more than two years of gruelling treatment for acute lymphoblastic leukaemia.

The fundraising was revealed in a surprise street party outside the family home in Elmwood Drive arranged for the day she 'rang the bell'.

Mum Nicola said: "We had asked a few people to come for a toast to celebrate her milestone and have a hotdog. But we returned to Disney princesses, a pony and an ice cream van!

"It was amazing and when friends revealed they had been raising funds to send Summer to Disneyland it totally blew our minds. It's been her dream to go to Disneyland and when it's safe to do so that's the first thing on our list.

"Seeing her face when they told her where she was going was such a magical moment for her and us. We could not believe how amazingly generous and caring our community is and we would like to thank everyone from the bottom of our hearts.

"Sarah (Nixon who led the fundraising) is the most amazing friend anyone could ask for - along with my other friends she has been there by my side constantly throughout Summer's treatment."

The terrifying cancer diagnosis came just five days after Summer's third birthday. She had been tired and kept getting an ear infection and, suspecting something was wrong, Dr Lily Lamb at Ponteland Medical Group sent her to Northumbria Specialist Emergency Care Hospital for blood tests.

Nicola said: "There we got the most devastating news of our life. They knew it was leukaemia and she was rushed to RVI for blood and platelet transfusions and to start immediate treatment.

"We were devastated – it felt like our whole world was ripped apart. It was so intensive and full on and Summer had to deal with so much. She has been the bravest strongest person we have ever met and never let it stop her."

Nicola, who is married to HMRC officer Steven and also has daughter Jordan, 21, son Bailey, 14, and daughter Layla, eight, left her job with Royal Mail at Ponteland Delivery Office to care for Summer.

She said: "Summer has been unbelievable in treatment. Even though she had to get a lot of horrible procedures done in hospital she always gave everything her all and was never scared to go, as she knew they were there to help her.

"We had to stay in hospital a lot as throughout treatment she had no immune system and caught a lot of bugs. The majority of the time she was neutropenic and could pick up bugs that would never bother a healthy immune system."

The Ponteland Primary School pupil still has a compromised immune system and will have to attend hospital regularly for blood counts for the next five years, and continue to have her heart monitored throughout her life.

The family have also had to come to terms with the tragic death of Steven's father Michael the day after Summer's celebration party, after a very short battle with pancreatic cancer.

Teenagers apprehended after deer killed

Two suspected teenage poachers were apprehended after reports of the killing of a deer near Ponteland.

Both young men have received advice in front of their parents after being found in the vicinity of the dead animal, which had been abandoned near Ogle in the early hours of September 5th.

Equipment suspected to have been used in poaching, including lamps, was seized from vehicles suspected to have been involved in the incident. As it could not be proved that the two suspects had killed the deer, they were instead taken home to their parents.

Operation Hawkeye, the force's new team dedicated to tackling rural crime, had responded to the call from a member of a public about the deer.

Rural Crime Team officer PC Alex Partington, one of the leading officers on the investigation, promised rural communities that patrols targeting poachers will continue.

He said: "Often we need to find poachers in the act to be able to bring forward criminal charges but what we can do is seize their equipment and force them out of the area. The response at the weekend was fantastic as they acted on local intelligence to hunt down two teenagers we believed to have been poaching.

"They may not face any criminal charges but we have seized a huge amount of equipment and they won't be returning to the countryside any time soon. This is only one recent example of ongoing efforts to tackle, disrupt and prevent rural crime across our force area.

"This positive police action will continue and will only strengthen our stance against anyone found to be committing or contributing to these types of crimes in the communities we serve."

Anti-social behaviour

Your local policing team has been conducting regular patrols in recent weeks in order to tackle anti-social behaviour by youths in the wooded area and by the River Pont behind Richmond Way, and the track leading from The Crescent to Limestone Lane. These patrols will continue for some time and police will deal robustly with any individuals identified as causing regular issues. I would ask parents and guardians to be wary about the whereabouts of their children, especially on weekends and in the evenings. I urge residents to report any incidents or concerns to police.

Warning to agricultural vehicles

Concerns have been raised by residents in outlying villages including Ogle and Whalton of heavy agricultural vehicles being driving at speed or in a careless manner. Members of the farming community are being reminded to drive appropriately, to be wary of their speed when driving through residential areas and to appropriately secure loads. Police will be conducting regular patrols in the area and will take action where necessary.

Speeding

In light of recent incidents in the Ponteland area, officers will be conducting regular Speedwatch operations and road policing patrols in the coming weeks in a bid to increase road safety. The Community Speedwatch initiative is back in operation with appropriate measures put in place in response to Covid-19. During Speedwatch operations conducted on September 3rd and 10th, 25 drivers were found speeding on North Road and Middle Drive. Officers from the team have conducted home visits and issued warnings to persistent speeding offenders.

Charity champ Bruce makes final donations

Ponteland charity champ Bruce Grant has made his final donations after a dedicated decade of fundraising.

The 93-year-old grandfatherof-five has paid £750 each to Tynedale Hospice at Home and The Royal Society for Blind Children.

Bruce, who has been a regular sight with his collection tin in Ponteland, Morpeth, Hexham, Kingston Park and Eldon Square in Newcastle over the years, has raised over £100,000 for good causes.

They include more than £70,000 for seven North East charities in the last three years alone - Newcastle People's Kitchen, West End Food Bank, West End Refugee Service, Benwell Cornerstone Project, Children North East, Percy Hedley Foundation and the

Great North Air Ambulance Service.

Bruce received a British Empire Medal in last year's Queen's Birthday Honours for his work with the Pont Charity Group and had been invited to a garden party at Buckingham Palace, but this sadly had to be cancelled due to Covid.

His latest donations came from the proceeds from his autobiography on his eventful life on land, air and sea entitled 'Flying by the seat of my pants', which the former engineer described as 'a collection of tales from boyhood, life at sea and in industry'. This has now sold out, with all 100 copies snapped up.

Bruce, of Old Station Court, Darras Hall, was close to death in June after suffering a chest infection and kidney failure. However, after being transferred into palliative care, he bounced back once

again and was allowed back home.

Its six en-suite bedrooms have new TVs and lighting, while a new outdoor dining and drinking space has also been created and furnished – offering stunning views of the River Coquet and a 16th century bridge.

Northumberland Pub Co's Stuart Young said: "I've admired The Northumberland

Power struggle continues at County Hall as Council Leader removed from office

The power struggle at the top at Northumberland County Council shows no sign of abating, with the Council Leader's removal the latest twist in a turbulent few weeks.

Ponteland South with Heddon ward councillor Peter Jackson lost a vote of no confidence in his leadership by a single vote – 33 to 32 – at a meeting of the full council on September 2nd.

The motion was tabled by the opposition Labour group, following the suspension of chief executive Daljit Lally OBE in August – a move which they described as "silencing".

Describing the previous month as "unbelievable", Labour leader Coun Susan Dungworth said: "We have seen breaches of the whistleblowing policy, members' emails disappearing overnight, major personal and professional data breaches, denial of audit committee meetings. Our reputation is in shreds; Northumberland County Council is the laughing stock of the region."

Three Cramlington Conservative councillors – Wayne Daley, Christine Dunbar and Mark Swinburn – voted against their leader, sealing his fate.

Coun Jackson's removal followed the resignation of three Cabinet colleagues – Ponteland West councillor Veronica Jones, who quit as portfolio holder for adult wellbeing and health, Coun Daley as Deputy Leader and Coun Cath Homer, the cabinet member for arts, culture, leisure and tourism.

The authority has said Mrs Lally, who has been chief executive since 2017 in a dual role which also sees her as Northumbria Healthcare NHS Foundation Trust's executive director of delivery, is "on a period of extended leave".

Her suspension followed two emails she sent on Friday August 7th. The first was sent to Cabinet members and raised concerns about Advance Northumberland, the council's development division, and alleged bias and potential conflict on the part of council leader Peter Jackson due to an alleged personal relationship.

The email, copied to deputy chief executive Kelly Angus, claimed Mrs Lally had no option but to follow advice and "put in place some referrals, investigations and measures to protect the council".

In a second email later the same day, sent to all councillors, she stated: "I have significant whistle blowing concerns that I have raised and that I am further raising as I am concerned about some issues in relation to the operation of the Council.

"I have received some limited responses to my concerns but I remain very concerned about my welfare and that of my exec/senior team and council business."

Coun Jackson has strenuously denied the allegations, saying: "All such claims are completely without foundation or evidence."

A formal disciplinary process is underway and, following national regulations, a committee of county councillors under an independent investigator has been established as a part of the disciplinary process. Kelly Angus has been appointed acting chief executive.

A new Council Leader was due to be elected by a meeting of the full council on September 23rd, and the electee will choose their cabinet.

Darras Hall Estate Committee's chairman says farewell and an appeal to support your local shops in this month's letters...

Estate Committee chairman says farewell

I'm currently looking out on my early autumn Darras Hall gardens, but now it's for the last time. I know I'll miss them.

Unfortunately, as a result of a change in personal circumstances, the family home is sold and the moving date is imminent. This means, of course, I can no longer act as your Chairman as I will no longer be an accessioned owner on the Estate.

So, this is my resignation and my goodbye. Six years ago I walked into my first meeting of the Darras Hall Estate Committee and walked out as Joint Chairman, becoming sole Chairman six months later. Recently retired, I wanted to channel the energy I still had into some kind of community service, I also wanted the challenge and intellectual stimulation of something new. I was not to be disappointed.

Over the last six years I have worked with the Committee and staff to modernise the operation both legally and practically. During my tenure, the archaic Trust was transformed into a Limited Company, electronic banking and card payments were introduced, a new website was built and the now extremely popular Darras Hall Facebook page was set up. All this, of course, was in addition to the normal business of the office, vetting plans, going on site visits, meeting representatives from local stakeholders, businesses etc.

One thing I learned very early on was that the majority of decisions made (usually in conjunction with the Committee) would never be universally popular. This is especially the case with planning. There is often an adversarial situation where the application is met with objections. Sometimes an application is also supported by other residents, battle lines are drawn!

I have always taken on board both sides of the argument and debated with the Committee accordingly. In complex cases, site visits are arranged and further evidence gathered. Occasionally a compromise is brokered, but often one side is happy and the other disappointed, so I become a hero and a villain at the same time.

Some residents think the Committee allow developers a free reign. Some developers think the Committee are unnecessarily obstructive. The ethos of Darras Hall was always close to my heart. Indeed, in one high profile case, the Committee incurred £25k in legal fees defending the Trust Deed.

It became increasingly obvious during my office that residents had much wider expectations of the committee than was our legal remit. Complaints would come into the office about nuisance neighbours, overgrown hedges, dangerous footpaths, blocked drains and potholes. None of these are within the jurisdiction of the Committee.

However, it was decided to follow up some persistent complaints on behalf of residents. Such was the outcry with regard to the condition of the roads and pavements that a working group was set up with NCC. One member of our Committee is now in regular communication with the county council with regard to this and I feel his efforts are beginning to bear fruit. Yes of course, it's inconvenient whilst the work is taking place, but no pain no gain. Please don't complain!

My departure obviously means there is a vacancy on the

Committee; in fact there are now a number of vacancies, as the Covid situation has meant previous departees haven't yet been replaced. So, any resident who feels they have something to offer, please contact the Estate Office now. Your committee needs you!

Anyway, life moves on and I must carve out a new one for myself away from Darras Hall. Thanks to the office staff who have worked hard and conscientiously and the Committee members who have worked with me over the last six years and thanks to all those residents who have supported me over the years; yes there are a few!

Thank you and goodbye.

Welcome to the project and community update

Over the past month, we have continued to make good progress having closed-out the teaching wings for both schools. The Crescent and Leisure Centre areas have progressed at pace and are on programme for completion by mid-October. Final testing, commissioning and training will then be completed in the period up to handover in early November 2020.

September has seen good progress to internal and external areas with finishing works well advanced throughout the site. Both Primary and Secondary School teaching wings have been completed, along with the shared areas to the Crescent. The public areas of the building have progressed well, with the final fix operations and equipment installations at an advanced stage. October will see the completion of all other areas including the remaining final testing and commissioning of the building's systems and equipment.

The Pool Hall has made really good progress through September with the finishes well advanced, pool deck tiling completed, wall tiling completed and the pool liner sheets installed to both pools. The installation of the height adjustable floor has also been completed ahead of the planned filling of the pools over the weekend of 3rd and 4th October. The Aqua Play equipment has been installed in parallel with the completion of the pools. Final testing and commissioning operations are due to be completed by mid-October.

The external areas have progressed well through September, aided by the good weather that we have had. Hard landscaping finishes are complete to the Crescent Park areas and around the Primary School. There has also been good progress to the northern section of the new southern car park and the new play park to the end of the public pedestrian bridleway, which were both completed during September.

Works have continued well to the public pedestrian bridleway, with the gabion basket walls to the overbridge at the Primary School being completed ahead of the final regrading of the path and installation of the dressed surface.

Works have advanced well to the new sports pitches across the Fairney Burn. The structural base to the 3G sports pitch and the multi-use games areas is complete with the pitch surfaces progressing for completion during October, ready for the opening of the campus later in the year.

Listed buildings from old police HQ going on sale

Listed buildings from Northumbria Police's former Ponteland headquarters will go on sale to house buyers later this year after being refurbished by Bellway.

The Newcastle-based housebuilder is converting a collection of Grade II listed cottages and the Superintendent's House into 22 homes.

Arcing around a large area of green open space, the renovated properties will form the centrepiece of Bellway's Ottermead at Jameson Manor development, which is part of a wider scheme of 275 homes being delivered by a consortium of Bellway and Ashberry Homes on the former police site.

The former force HQ, off North Road, opened in 1981 but the 57-acre site was sold to Bellway for £21m in 2018. Although the listed buildings are being retained, most of the other buildings were demolished after being deemed no longer fit for purpose.

The proceeds from the land sale have been re-invested in local policing and the force has moved into a new headquarters to the south of the site.

The listed buildings date back to well before the site was occupied by the police, with the cottages being built in the early 1900s to house children away from the Newcastle workhouses.

"The most popular classes were for dahlias and runner beans but there was a total of 222 entries from 50 entrants including eight children and a beautiful rainbow made from woollen pompoms by residents at Ponteland Manor.

"A special class for a lockdown project illustrated a wide range of interests from a garden pond to painted stones and home made cocktails.


boutique than a charity shop."
