### 1. PLANNING APPLICATIONS

**1.1** Application No: 19/02754/FUL, Location: land north of 7 Ladywell Way, Ponteland, NE20 9TE. Proposal: One no 3-bedroom dwelling, with associated parking and garage; new access to the proposed development will need to be created off Ladywell Way A submission was made by one of the objectors. 2.1 DECISION: 19/02009/FUL: 15 Avondale Road, Darras Hall, Ponteland, NE20 9NA: Remodelling current Dutch bungalow from (currently) three bedrooms with severe sloping roofs to 4 bedrooms (without sloping roofs), ensuite and family bathroom.

NCC had advised that permission had been granted.

The Committee had not commented on this application.
