1. PLANNING APPLICATIONS

2. <u>DECISIONS: APPLICATIONS AND APPEALS; WITHDRAWN APPLICATIONS</u>

2.1 DECISION: 20/02166/FUL, 67 Woodside, Darras Hall, Ponteland, NE20 9JB. Proposed removal of existing garage and off shot. Erection of side and rear extension. Existing roof removed replaced with new roof with higher ridge height. Internal alterations to existing layout. New dormers to front elevation. New garage to be erected. Existing tree removed as amended by drawings received 23/7/2020

Permission **GRANTED** under delegated powers on 30th September 2020. The Committee had made no comment about this application.

2.2 DECISION: 20/02570/FUL, Woodside Ponteland NE20 0DG. Replacement garden room with part extension above to provide bedroom.

Permission **GRANTED** under delegated powers on 2nd October 2020. The Committee had made no comment about this application.

- 2.3 DECISION: 20/02613/FUL, 29 Kirkley Drive, Ponteland, NE20 9QP. Proposed construction of single storey extension to the rear and side of existing rear extension. Permission GRANTED under delegated powers on 6th October 2020. The Committee had made no comment about this application.
- 2.4 DECISION: 20/02247/FUL, Land South of Middle Coldcoats, Equestrian, Milbourne. Proposed erection of a rural workers dwelling.

2.5 DECISION: 20/02702/FUL, 7 Oaklands, Darras Hall, Ponteland, NE20 9PH. Proposed refurbishment of the property comprising of existing ground floor flat roof to be replaced by pitched roof, ground floor porch and garage rendering, partial garage conversion providing utility room and minor internal works.
