MINUTES OF THE PLANNING COMMITTEE MEETING 26th April 2022

1. PLANNING APPLICATIONS

A list of planning applications received since the previous Committee meeting had been circulated

Councillor Mrs S Johnson declared an interest on Application No: 22/00706/FUL Location: 27 Main Street, Ponteland, Northumberland NE20 9NH. Proposal: Replacement extension, new canopy to main entrance, dormer for safe roof access, creation 2No. Click & Collect & 2No. Van bays in carpark, relocation of cycle rack and trolley ay as well as external works including re surfacing (& pin kerb installation) near warehouse access and repainting of elevations, doors windows and canopy frames.

The Committee made no comments about the 4 applications considered.

2. DECISIONS: APPLICATIONS AND APPEALS; WITHDRAWN APPLICATIONS

2.1 DECISION: 21/04725/FUL, 12 Callerton Court, Darras Hall, Ponteland, NE20 9EN. Proposed formation of flat-roofed dormer to the rear in place of existing pitched roofed dormer.

Permission **granted** under delegated powers on 22nd April 2022. The Committee had made no comment about this application.

2.2 DECISION: 21/04681/FUL, 186 Darras Road, Darras Hall, Ponteland, NE20 9AF. Proposed garage and kitchen extension with new entrance hallway and new roof to form first floor with 8.5m ridge height.

Permission **granted** under delegated powers on 22 April 2022. The Committee had made no comment about this application.

2.3 DECISION: 22/00727/VARYCO, East Town Farm Cottage, Milbourne, Ponteland, NE20 0EE. Proposed variation of condition 1 (approved plans) on approved application 21/03280/FUL to allow addition of entrance porch.

Permission **granted** under delegated powers on 22nd April 2022. The Committee had made no comment about this application.

3.1 Application No: 22/01025/FUL, Location: 2 Fellside, Darras Hall, Ponteland NE20 9JW. Proposal: Rear flat roof dormer.
