#### 2. DECISIONS: APPLICATIONS AND APPEALS; WITHDRAWN APPLICATIONS

#### 2.1 DECISION: 22/04222/PRUTPO

#### 7 Middlebrook, Darras Hall, Ponteland, Newcastle upon Tyne, NE20 9XH

Proposed: TPO Application – Oak x 4 reduce crown by 4 meters and remove epicormic growth The application was **REFUSED** on 22<sup>nd</sup> December 2022.

The Committee had referred this application to the Tree Officer.

# 2.2 DECISION: 22/04203/VARYCO 32 Eland Edge, Ponteland, NE20 9AY.

Variation of condition 2 (approved plans) on approved application 20/00250 /FUL in order to build the rear extension wider than approved, but still projection 3m.

The application was **GRANTED** on 22<sup>nd</sup> December 2022.

#### 23 Stonehaugh Way, Darras Hall, Ponteland NE20 9LX

Alterations to entrance including additional gates/pillars and change position. New porch entrance, side extension, rear extension, first floor extension

with works including internal alterations to room layouts, new staircase, gable windows, en-suite and study and garden room to north east of site.

#### The Dairy, Callerton Hall Drive, High Callerton, Ponteland, NE20 9TT

Extension to existing detached garage building to create a 'pool house'.

The Planning Committee feel that this application, adjoining a previously approved development, will now display excessive development in a greenbelt area and in addition the property sits within a designated conservation area.
